**VISION 2024 FOCUS AREA:** Enhancing the health of neighborhoods by promoting well-being for all through safety, infrastructure, housing, connectivity, recreational space, and community engagement.

**SUMMARY/BACKGROUND:** A traffic engineering consultant has recently completed a speed study on 19 roadways in the Town. Initial draft study reports were submitted in October 2023. The reports were finalized in February 2024. Results were presented to the Town Council in a Study Session held March 7, 2024.

Town Code 11-02-040 recognizes the authority granted by ARS §28-703 to establish local speed limits based on traffic engineering studies. Such studies must take into account roadway environment and character, geographic context, collision history, and speed distributions (i.e., pace speed, median speed, and 85th percentile speed). In the past, the 85th percentile speed has been the primary basis for setting speed limits. More recently, however, the other listed factors have been considered as crucial in setting speed limits that support and promote all users within the public right-of-way. Appropriate speed limits promote roadway safety while maintaining traffic circulation and roadway connectivity (and encourage compliance by drivers).

The final study report has identified a need for 5-mph speed limit increases on four streets within the Town:

Prescott East Highway; Antelope Lane to Granville Fairway

Granville Fairway; Santa Fe Loop Road to Tuscany Way

Santa Fe Loop Road; Jasper Parkway to Glassford Hill Road

Tuscany Way; Glassford Hill Road to Santa Fe Loop Road to Glassford Hill Road

It is proposed that the Town Council now consider adopting Resolution No. 2024-2366 changing the speeds on the four identified street sections.
