SUMMARY BACKGROUND: On February 12, 2015 Town Council approved design and construction services for a new steel building at the Wastewater Treatment Plant (WWTP). The building will be used primarily as a storage facility for equipment that is susceptible to damage / inoperability during winter conditions.

The 3,000 square foot facility was developed by Stroh Architecture, Inc. in collaboration with civil design per Town Engineer, Dava & Associates, Inc. The WWTP is shown in Figure 1 and the proposed location of the building is illustrated as a rectangular black box, east of the main office building.

An invitation to bid for construction was advertised for two consecutive Sundays starting May 3, 2015, and seven (7) bid submittals were received per Table 1 below.

The lowest bid exceeds available funding by approximately \$50,000, therefore, Town staff recommends rejecting all bids. Staff proposes: 1) modifying the scope of the project after consultation with the Architect and Town Engineer and 2) re-advertising in Fiscal Year 15/16.

OPTION ANALYSIS: The Council may vote to:

- 1.) Reject all bids **AND** direct staff to modify the scope of this project, as recommended, **OR**
- 2.) direct staff to pursue other options.

ACTION OPTION: Motion to reject all bids and direct staff to modify the scope of the Treatment Plant Equipment Storage Building, CIP # W372. **VOTE.**

RECOMMENDATION: Town staff recommends rejecting all bids for the Treatment Plant Equipment Storage Building, CIP # W372 and directing staff to modify the project scope.
