The Town of Prescott Valley is seeking bids for **Roadway Maintenance Materials (Cold Mix Asphalt, ABC Base, Hot Mix Asphalt, Slurry and Concrete)** for purchase during the fiscal year beginning July 1, 2015. All bids must be clearly marked “**Roadway Maintenance Materials**”, placed in a sealed envelope, and received no later than **3:30 PM MST on Monday, April 27, 2015**. Bids may be hand-delivered or mailed to the Town Clerk’s Office at 7501 E. Civic Circle, Prescott Valley, Arizona, 86314. At the above time and date, all apparent responsive bids shall be opened and read aloud. The Town of Prescott Valley reserves the right to accept or reject any or all bids.

The Town of Prescott Valley is seeking bids for Roadway Maintenance Materials over a 12-month period starting July 1, 2015 and ending on June 30, 2016.

The Town of Prescott Valley desires to purchase:

- (1) Cold Mix Asphalt (commercial grade)

Amount quoted: \$ 93.00 91.50 
(per ton, FOB)

- (2) Hot Mix Asphalt (commercial grade, gradation and oil to be per Vendor's current scheduled production run). Town shall be notified of mix design, per MAG 710, before acceptance and loading of materials)

Amount quoted: \$ 65.00
(per ton, FOB)

- (3) Aggregate Base in compliance with YAG 702.2 "Crushed Aggregate"

Amount quoted: \$ 7.15 Spec ABC
(per ton, FOB)

- (4) Shoulder backing material

Amount quoted \$ 6.50 Graded ABC / 4.50 Select A (See Attached test)
(per ton, FOB)

Material:

Aggregate for select material shall consist of stone, gravel, or other approved inert material of similar characteristics, and shall be clean and free from organic matter and other deleterious substances. The use of volcanic cinders will not be allowed. The select material shall have a plasticity index (PI) of not less than four (4) and not to exceed fifteen (15), and shall conform to the following gradation:

<u>Sieve Size</u>	<u>Percent Passing</u>	<u>Select A</u>
1-1/2"	100	100
3/4"	90-100	94
1/2"	65-95	86
No. 4	33-60	95
No. 8	21-42	75
No. 30	8-24	25

The percentage by weight passing each sieve will be determined in accordance with the requirements of Arizona Test Method 201.

The bid amount for Items 1, 2, 3 & 4 are per ton, Freight on Board (FOB) at the Vendor's yard. Loading onto a Town truck is to be included in the bid price per ton. Sales Tax is not to be included in the bid price.

The bid amounts for Items 5 & 6 are per cubic yard, delivered to the work site in Prescott Valley. All transport and delivery costs are to be included in the bid price per cubic yard. Sales Tax is not to be included in the bid price.

The Vendor's yard can be no further than five miles from the Prescott Valley Town boundary.

The Town of Prescott Valley reserves the right to segregate all bids into separate items and to award separate contracts based on the lowest responsive bids in each category.

The Town of Prescott Valley has adopted the "Uniform Standard Specifications for Public Works Construction" and the "Uniform Standard Details for Public Works Construction" as sponsored and distributed by the Maricopa Association of Governments, Arizona and is supplemented by Central Yavapai County Government Unified Construction Standards. By this reference, these standards are incorporated into these Project Specifications.

The successful Bidder/Vendor must have a Prescott Valley Business License at the time of selection and must carry standard commercial liability insurance in the amount of \$1,000,000.

The Town reserves the right to accept or reject any or all bids, based on the Town's best interest.


All bids must be submitted on the entire document titled "ROADWAY MAINTENANCE MATERIALS BID SPECIFICATIONS/CONTRACT" as contained herein, and must be sealed, marked "ROADWAY MAINTENANCE MATERIALS", and received at the Office of the Town Clerk prior to the stated bid time.

The Town of Prescott Valley reserves the right to rescind this Contract upon fifteen (15) calendar days written notice, addressed to the Agent of the successful Bidder/Vendor as listed herein.
